
Ordering Window

Because your Order portal is on the same platform as your AP, Agencies are automatically put on hold when past due, or over their credit limit.




Search by Product

Agencies can shop against recurring appointments, which are configured by your organization.





Agency Restrictions

Shoppers only see products from approved Programs for their Agency. A "Max Quantity" is shown, which can differ by Agency.




Reschedule/Cancel Online

Agencies can notify Food Banks right from the portal when needing to reschedule or cancel their pickup.

Food Planning

With Netsuite, Purchase Orders, Inventory, and Sales Orders are all part of the same system. For this reason, *Food Banking for NetSuite* allows Food Banks to offer inventory for distribution before it even lands in your Warehouse.



Available to Promise

"Available To Promise", is selected on any Purchase Order where Expected Receipt Date is accurately forecasted.

Lot Expiration

Automatically prevent orders of inventory that is expected to expire before the pickup date. Automatic notifications prompt you to re-code, or damage out.

Put-Away Time

Configure "Put-Away Time" from 0-3 days, so inventory expected on Monday can be fulfilled same day, or 2 days after.

Demand Planning

Leverage your historical distribution data to plan for future demand. Line up forecasts against supply plans to determine where gaps are present.

Agency Restrictions

Configure Agency Restrictions to prevent Agencies from receiving Food from nonauthorized programs. Automatically balance inventory across Agencies to achieve equal distribution for Push models.



Restrict by Program

Restrict agencies to one or more of your Programs.

Maximum Distributions

Track maximum distributions by Agency to prevent over-ordering or over distribution.

Restrict by Location

Restrict distribution to Agencies by location.

Custom Restrictions

Use any field on the Agency record to setup restrictions as they apply to Federal, State, or Local programs.

Food Acquisition

As costs change, the sale price of food updates automatically whether your organization distributes at cost, at cost +%,


